### Reserving the Unit

Backyard Amusements requires a minimum of 50% deposit before the reserved date can be confirmed. The balance is due upon arrival to your event, prior to your start time. A valid major credit card and drivers license is required to hold the reservation. Nobody under the age of 18 may rent the units.

### Invalid/Declined Credit Card

In the event that a credit card is denied, a reservation cannot be held and a \$15 transaction fee in cash will be expected. A valid credit card must be used to hold the reservation. Customer will be liable for any and all legal or collection costs.

### Before We Arrive

The surface must be FLAT and clear of ANYTHING that can puncture or damage the unit. This includes rocks, sharp gravel, sticks, fireweed, tree roots, stumps, trash, oils, etc. which can damage the unit. Grass is the best area for these units, not dirt, weeds or gravel. You must notify us if not on grass. Please do not mow lawn the day of event to keep grass clippings out of unit. Units need open and clear space no less than 10 feet on either side of it. You must determine a location for the unit before we arrive. We reserve the right to cancel due to site being unsafe for unit. **If upon arrival it is determined that the site is unsafe for setup, full payment will still be required.** If site has to be cleaned or cleared after we arrive, your time will not be extended. You are responsible for cleaning and clearing the area for unit placement. If you have a fence, a hilly area, we are unable to get to location with the trailer, or location is hard to get to, someone strong must be available to help move unit to location. If nobody is available to help, we reserve the right to cancel and full payment will still be expected.

If units are not going to be on grass but on pavement, you must notify us in advance. If we are not notified in advance, full payment will still be expected even if the unit cannot be set up. **We will not set up on sharp gravel driveways or sharp gravel parking lots.**

We will be pulling a 16 foot trailer, please let us know before we arrive the best way to get to your location and be able to turn around. If you do not let us know how to turn around before we arrive and we cannot get turned around, you will pay us for our time at \$50 for every 15 minutes of time extra that we are there.

### Rental Time

Time rented is time that the unit is actually in service. Time rented does not include the set up time or take down time but actual use of the unit. We usually arrive 30 minutes to one hour before the event, someone must be there upon arrival or we will assume event has been cancelled and full payment will be charged. Sometimes we will be earlier or arrive late for pickup, someone must stay with the unit until pickup. Do not turn off the unit unless weather conditions deem it necessary.

### Cancellations

Although we rarely cancel any events, we do reserve the right to cancel an event for any reason whatsoever, including mechanical problems, weather, circumstances which make the unit unsafe, or emergencies. If we cancel an event, we will refund all payments in full. Backyard Amusements will not be held responsible for any expenses incurred by you to prepare for your event. Failure to make full payment on reservation upon arrival, or unoccupied event are considered to be a cancellation by you, the client, and there will be no refunds.

Client can cancel event at least 14 days in advance and receive a full refund, less at \$25 processing fee. **All cancellations that are not made within the 14 day advance notice will not be refunded and full payment is expected.**

Weather Cancellations-. If weather conditions prevent unit from being set up, there will be a \$25 processing fee, which can be applied to reschedule of event within 30 days of original event. If you do not cancel before we arrive, full payment will be expected. Weather cancellations can be left to our discretion. Events may be delayed or cut short due to weather without any refunds. If you chose to have a party at Bonkers Play Center due to weather, full payment will still be expected.

### Damage to Unit

If it is determined that the unit was damaged in anyway, you will be liable for any and all damages including loss of time up to \$8000. If unit is returned with gum, silly string, wet(except waterslides), food, drinks, popcorn, stained from *anything*, or excessively dirty or muddy, a cleaning fee up to \$1500 may be charged. **By renting the unit, you accept full responsibility of keeping it safe and clean.**

## SAFETY INSTRUCTIONS

Your children's safety is our number one priority. You must carefully read and be aware of all of the safety rules before operating unit and must comply with them at all times. The following rules detail safe operational guidelines for the inflatable equipment that you are renting from Backyard Amusements. A responsible adult must supervise the inflatable unit at all times when in use. The adult must be aware of all of the safety rules and be the enforcer of these rules. **The customer is responsible for the safety of the children and care of the equipment.**

**10x10 Economy** no more than 5 children under 8years old Unit is not made for older children.

**13x13 Balloon** 3-6yrs old :8children, 7-10 up to6children, 11-14 up to 4 children, 14 up- 2 max

**13x20 Castle** 3-6yrs old: 8children 7-10 up to 6children, 11-14 up to 4 children, 14 up-:2 max

**Dbl waterslide** 5-9 yrs old: 5 children 10-12 yrs old: 4 children 13 up-3 max

**Tunnel Maze** No one over the age of 7 years old is allowed in unit. Customer is responsible for balls staying in unit.

**Giant waterslide** Holds up to 400 lbs, only one person at a time down slide, always feet first.

1. \_\_\_\_\_ Only compatible age groups, size and weight are allowed in unit at the same time. The following are the guidelines and should be enforced by the customer. **IT IS UNSAFE TO MIX AGES AND SIZE.**

2. \_\_\_\_\_ All riders must remove shoes, glasses, loose jewelry, long earrings,belts, or any other object which might puncture unit before playing in unit. All pockets are to be empty upon entering unit.

3. \_\_\_\_\_ **No flips, cartwheels or somersaults of anykind. This may cause injury, disability or death.**

4. \_\_\_\_\_ Units may not be moved from original position.

5. \_\_\_\_\_ All riders must obey safety rules posted on unit at all times. An adult must enforce these rules at all times and ask child to leave if not in compliance with safety rules.

6. \_\_\_\_\_ Unit is not to be near swimming pools or water. Unless renting a waterslide, units are not to get wet for any reason, this includes from a sprinkler, water balloons, hose, or wet children.

7. \_\_\_\_\_ Riders must be assisted in and out of unit at all times.

8. \_\_\_\_\_ **No food, drinks, gum, candy, silly string, balloons, or bubbles** allowed in unit. A cleaning fee will apply (see below).

9. \_\_\_\_\_ No pets allowed in unit.

10. \_\_\_\_\_ Children/adults should never climb or hang from net either from inside or outside unit. It may cause the unit to flip over and cause injury or death to riders.

11. \_\_\_\_\_ Riders should never wrestle, pile on others, jump on others, or push others down while using unit.

12. \_\_\_\_\_ Nobody with pre-existing health conditions or injuries such as but not limited to: pregnancy, heart conditions, epilepsy, children in casts, joint injuries, etc. shall be allowed in or on the unit at any time.

13. \_\_\_\_\_ Nobody should be allowed to sit on entrance ramp at any time.

14. \_\_\_\_\_ Once the weather becomes unsafe, including strong winds (15 mph) riders must exit the unit immediately and blower must be shut off. In the event of rain, snow or lightning, blower must be immediately unplugged from outlet after riders have exited the unit. If it rains, turn unit off and cover with tarp.

15. \_\_\_\_\_ Balls and balloons are not allowed in unit.

16. \_\_\_\_\_ **Slide unit safety** If renting a slide unit, please read carefully extra safety rules for slides:

Riders must never jump off of slide, riders must always go down slide feet first, riders must never stand on slide, after going down the slide, rider must move out of the way. No unattended infants or toddlers allowed near waterslide pool.

17. \_\_\_\_\_ **Negligence or Abuse**-The following fees will be assessed for negligence or abuse of the unit.

Food, drink, gum, candy, silly string, bubbles will result in a \$300-\$1500 cleaning fee

Water, excessive mud or dirt, popped balloons will result in \$200-\$500 cleaning fee.

Grease, oil, chemicals, face paint will result in \$800-\$3000 cleaning fee

**If unit is punctured, torn, or ripped a \$3500-\$8000 fee will be charged.**

18. \_\_\_\_\_ **Deflation**- If the unit deflates, immediately have the riders exit the unit.Next, if the blower has stopped running, check to see if it has become unplugged. If so, turn blower off and plug it back in, then turn the blower back on. If blower is still running, check the both the blower tubes on the inflatable unit to make sure that they are tightly tied off. Never allow any riders in unit if it has deflated or partially deflated. If unit still is not working properly, immediately call **Backyard Amusements at 388-5787. Do not attempt to repair unit other than described above.**

19. \_\_\_\_\_ **Invalid/Declined Credit Card**- In the event that a credit card is declined or invalid for any reason, a\$15 fee will be incurred as well as customer is liable for any and all collection fees. Payment will immediately be expected in cash.
